

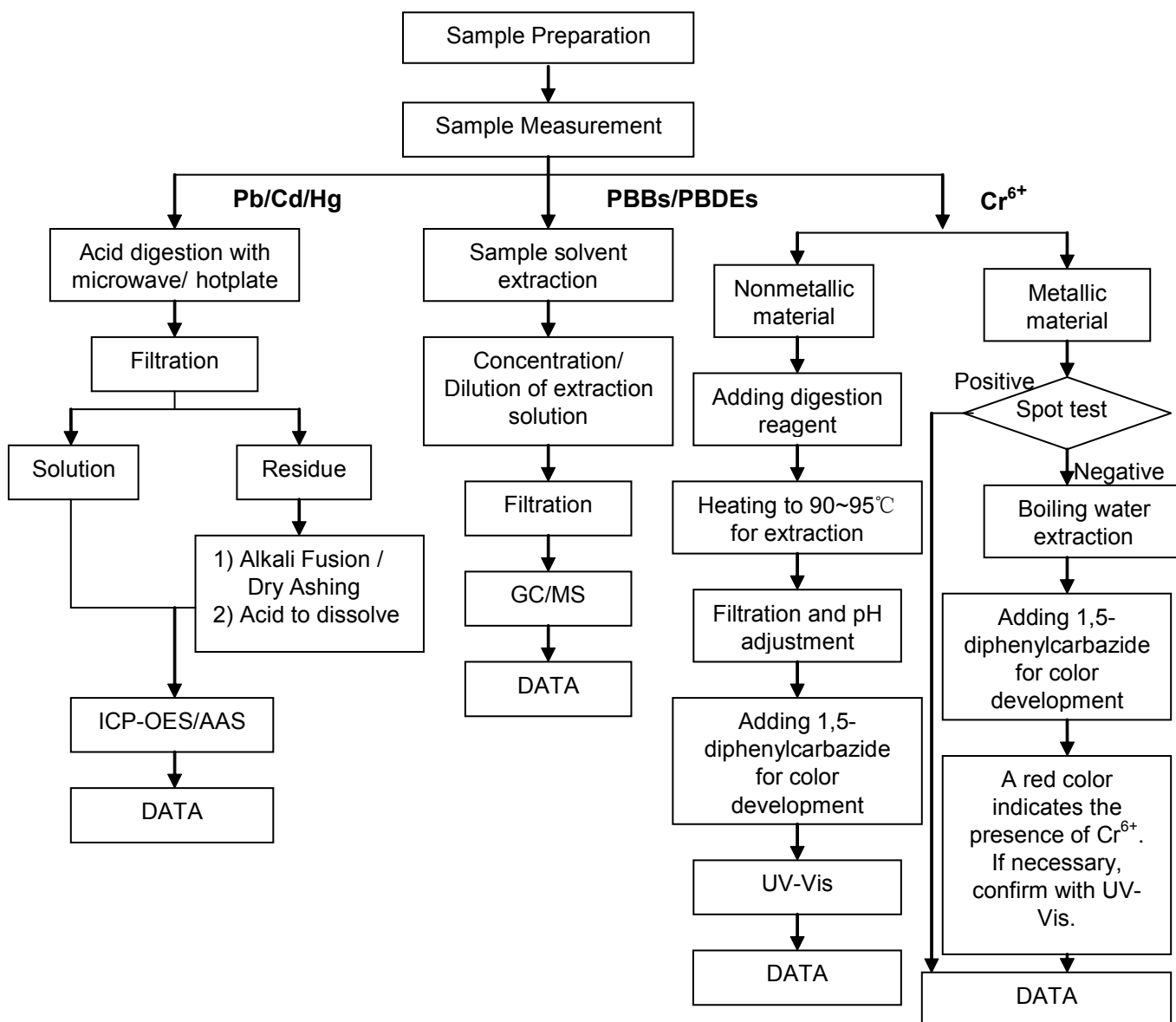

RoHS Testing Flow Chart

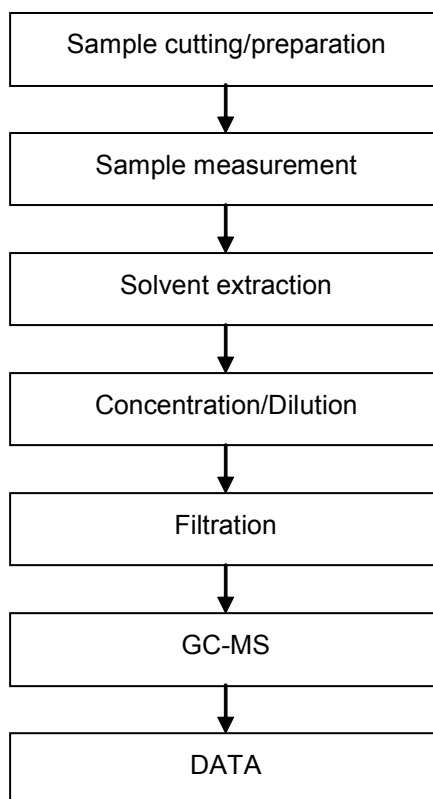

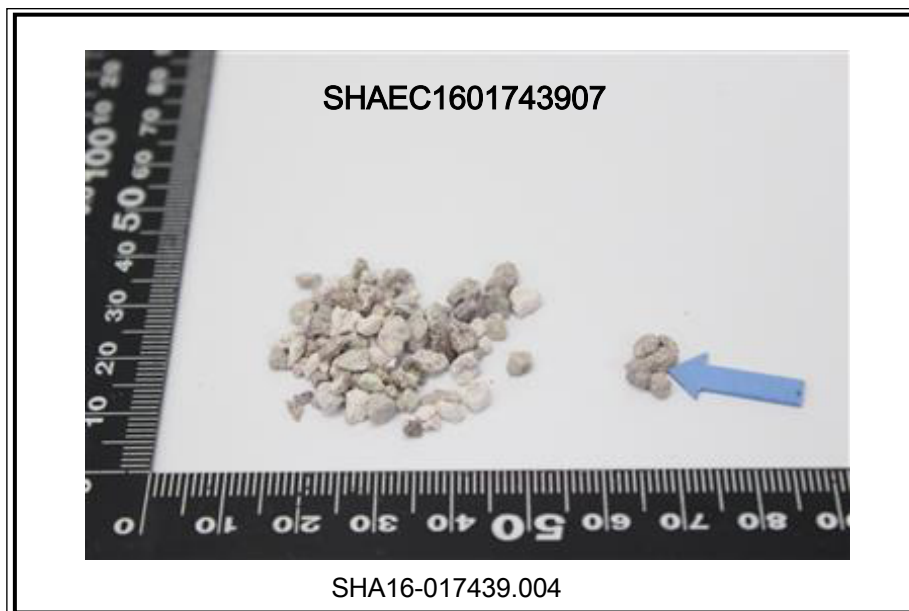
